An evidence-informed home visiting partnership, Book Babies provides support to enrolled families that begins when a baby is born and is sustained over five years. Book Babies builds rich relationships and provides families with the information and resources they need to develop the foundation for their children's school readiness and school success. In 2019, 314 babies were enrolled in BB, 689 babies and siblings received a total of 8,660 books and 646 home visits were made by home visitors.

4b (Code: ) (Expenses \$ 280,374 including grants of \$ ) (Revenue \$ ) Books and Beyond creates and promotes a culture of literacy for families and children in community spaces they regularly visit. In 2019, we expanded our presence in Laundromats in Durham, NC, providing story-times and literacy programming every week in three neighborhood locations. Children and families had the opportunity to select and take home an unlimited number of free books from bookshelves displayed in cozy reading spaces in the laundromats. 689 children participate, 186 story-times provided, and 10,696 books were provided.
